








## Transport conditions for the acceptance of Dangerous Goods



	<p><b>Aerosols</b> for sporting or home use</p> <ul style="list-style-type: none"> <li>• With no subsidiary risk, containing non-flammable, non-toxic gas only.</li> <li>• The release valves must be protected by a cap or other suitable means to prevent inadvertent release of the contents.</li> </ul> <p><i>NOTE:</i> See also the conditions for non-radioactive medicinal or toilet articles as the total net quantity carried per person is limited.</p>	No	No	Yes
	<p><b>Alcoholic beverages</b></p> <ul style="list-style-type: none"> <li>• In retail packagings, containing not more than 70% alcohol by volume, and</li> <li>• in receptacles not exceeding 5L.</li> <li>• A total net quantity of 5L per person.</li> </ul>	No	Yes	Yes
	<p><b>Avalanche rescue backpack, equipped with a pyrotechnic trigger</b></p> <ul style="list-style-type: none"> <li>• 1 backpack per passenger.</li> <li>• The pyrotechnic trigger mechanism containing less than 200mg net of Div. 1.4S and less than 250 mL of compressed gas in Div. 2.2.</li> <li>• The backpack must be packed in such a manner that it cannot be accidentally activated.</li> <li>• The airbags within the backpacks must be fitted with pressure relief valves.</li> </ul>	Yes	Yes	Yes




	<b>Battery-powered mobility devices with spillable batteries</b>	Refer to the transport conditions of wheelchairs or other battery-powered mobility devices with spillable batteries.	Yes	No	No
	<b>Camping stoves and fuel containers that have contained a flammable liquid fluid</b>	Camping stoves and fuel containers/tanks: <ul style="list-style-type: none"> <li>• have to be fully drained of all liquid fuel.</li> <li>• must have a cap securely fastened.</li> <li>• must be wrapped in an absorbent material (e.g. a paper towel) and placed in a polyethylene or equivalent bag.</li> <li>• The top of the bag must then be sealed or gathered and closed with an elastic band or twine.</li> </ul>	Yes	No	Yes



 <p><b>Consumer electronic devices, containing lithium metal or lithium ion cells or batteries</b> (e.g watches, calculating machines, cameras, cellular phones, lap-top computers, camcorders)</p>	<ul style="list-style-type: none"> <li>For personal use.</li> <li>Spare batteries must be                             <ul style="list-style-type: none"> <li>individually protected to prevent short circuits by placement in the original retail packaging or by otherwise insulating terminals, and</li> <li>may only be carried in hand baggage.</li> </ul> </li> <li>Each installed or spare battery must not exceed the following:                             <ul style="list-style-type: none"> <li>for lithium metal or lithium alloy batteries, a lithium content of not more than 2 g</li> <li>for lithium ion batteries, a watt-hour rating of not more than 100 Wh.</li> </ul> </li> </ul> <p><i>NOTE:</i> see also the conditions for Spare lithium metal or lithium ion cells or batteries</p>		No	Yes	Yes

	<b>Energy efficient light bulbs</b>	<ul style="list-style-type: none"> <li>In retail packaging intended for personal or home use</li> </ul>	No	Yes	Yes

 <p><b>Heat producing articles</b> such as underwater torches (diving lamps) and soldering irons</p>	<p>Battery-powered equipment capable of generating extreme heat, which would cause a fire if activated (e.g. high-intensity lamps):</p> <ul style="list-style-type: none"> <li>• has to be switched off.</li> <li>• The heat producing component or the battery has to be removed and packed separately so as to prevent activation during transport.</li> <li>• Any battery that has been removed must be protected against short circuit.</li> </ul>	Yes	Yes	No
 <p><b>Hair curlers containing hydrocarbon gas</b></p>	<ul style="list-style-type: none"> <li>• 1 per passenger.</li> <li>• The safety cover must be securely fitted over the heating element.</li> <li>• The hair curler must not be used on board at any time.</li> <li>• Gas refills are not permitted in checked or in carry-on baggage.</li> </ul>	No	Yes	Yes

	<p><b>Lithium ion batteries</b></p> <ul style="list-style-type: none"> <li>• For the operation of consumer electronic devices, and</li> <li>• with a Watt-hour rating exceeding 100 Wh but not exceeding 160 Wh.</li> <li>• No more than 2 spare batteries must be carried in carry-on baggage only:               <ul style="list-style-type: none"> <li>- these batteries must be individually protected to prevent short circuits.</li> </ul> </li> <li>• Equipment containing such batteries may be in checked or in carry-on baggage.</li> </ul> <p><i>NOTE: for lithium ion batteries with a watt-hour rating of not more than 100Wh see 'Spare lithium metal or lithium ion cells or batteries'</i></p>	Yes	Yes	No

 <p><b>Wheelchairs or other battery-powered mobility devices with spillable batteries</b></p>	<p>Mobility aids powered by spillable (wet) batteries <b>may only be transported as cargo.</b></p> <p><i>NOTE:</i> this is an operator's variation to the IATA Dangerous Goods Regulation.</p>	Yes	No	No
